WEX PHARMACEUTICALS INC. ANNOUNCES ABSTRACT AND POSTER PRESENTATION AT PAIN IN EUROPE XIII: THE 13TH CONGRESS OF THE EUROPEAN PAIN FEDERATION EFIC® ON THE LEAD COMPOUND, TTX (HALNEURON®)

Vancouver, BC (September 26, 2023) - WEX Pharmaceuticals Inc. ("WEX" or the "Company"), a clinical-stage biotechnology company developing Halneuron® (Tetrodotoxin or TTX) for pain, is pleased to announce the presentation of a scientific poster on Halneuron® at the 13th Congress of the European Pain Federation (EFIC®) in Budapest, Hungary on September 20th, 2023. This was one of the largest international congresses on pain in 2023.

The poster titled "Reduced Pain and Regional Brain Activation Following Tetrodotoxin (TTX) Treatment in a Cynomolgus Model of Post-Operative Pain" was presented by Donald Wong, Ph.D., Translational Research Manager, WEX Pharmaceuticals Inc. This non-clinical experiment studied the activities of the brain by functional magnetic resonance imaging (fMRI) after treatment using Halneuron (the "Study"). The Study demonstrated that the major pain centers in the brain, the insular and secondary somatosensory cortex, were deactivated through the inhibition of peripheral nerves by TTX. Dr. Donald Wong stated, "We continue to unravel TTX's mechanism of action in pain relief. We have previously shown that TTX administered subcutaneously reduces peripheral nerve activities and provides pain relief without crossing the blood-brain barrier. Here, we extend our findings by studying the brain itself. The action of TTX in the periphery leading to the reduction of the activities in the major centers in the brain involved in pain may be used as an objective biomarker for treatment efficacy."

Mr. Walter Korz, Chief Executive Officer of WEX Pharmaceuticals stated, "The Study showed how Halneuron acted on the peripheral nervous system and has a direct down regulation of pain perception by the brain providing further evidence of TTX's pain relieving properties and its possible use for post surgical pain."

Halneuron® is an injectable formulation of Tetrodotoxin, a novel small molecule with action exclusively on the peripheral nervous system. Halneuron does not cross the blood-brain barrier and therefore is without the common side effects of euphoria, addiction, tolerance, sedation, and confusion experienced by opioids and other analgesics. Pharmacology studies revealed that TTX is a



more potent analgesic than standard analgesic agents such as aspirin, morphine, or meperidine, with potential applications in many moderate to severe neuropathic pain conditions.
